TAGCO MET EmployerDirect Plan 3848 (01) has a calendar year deductible of \$200 that applies to Part B benefit only; such deductible applies towards the Part B out-of-pocket (OOP) maximum; pays the Part A deductible, but does not pay the Part B deductible; Plan pays 16% (80%) of Part B coinsurance up to \$2,000 out-of-pocket (OOP) expense by the insured; thereafter, it pays 100% of Part B coinsurance; Plan pays for Part A additional 365 days; Plan pays 100% for excess coverage on unassigned Medicare claims; **Plan 3848 (01) is fully insured and underwritten by Hartford Life & Accident Insurance Company** and does not include Rx coverage; Plan is composite rated;

³ A benefit period begins on the first day you receive service as an inpatient in a hospital and ends after you have been out of the hospital and have not received skilled care in any other facility for 60 days in a row.

⁴ If any of the cancer screening tests are not covered by Medicare, the plan will pay the usual and customary charges incurred.

⁵ The \$250 Foreign Travel Deductible is a separate deductible, and does not apply towards the \$200 Calendar Year Deductible.
